Instructions for Use: Acentra Health is a Beneficiary and Family Centered Care Quality Improvement Organization (BFCC-QIO) for Medicare. We help people with Medicare when they believe their care is ending too soon or have a concern about their care. Our services include Immediate Advocacy, a free process that helps resolve care issues quickly, often while the person is still receiving care.

Use the LinkedIn post templates below to share a new 2-minute video that helps Medicare beneficiaries understand their rights and how to get help when they need it most.

These sample LinkedIn posts are designed for stakeholder organizations that work with Medicare beneficiaries.

How to Use:

- 1. Choose the post version that best fits your organization's style (short or expanded).
- 2. Copy and paste the text into a new LinkedIn post from your organization's LinkedIn account.
- 3. Optionally, tag Acentra Health and use the provided hashtags to improve visibility.
- 4. To make your post more engaging, we recommend including a photo or graphic that helps the message stand out in the LinkedIn feed. Here are a few ideas:
 - a. A simple image showing a Medicare beneficiary (older adult) or caregiver in a care setting.
 - b. A graphic with the title: "Know Your Medicare Rights Watch the 2-Minute Video."
 - c. An image that reflects support, advocacy, or care transitions.
 - d. Use your organization's branding or colors if you're designing your own image.
